The M&A Forum will be back in December 2023.

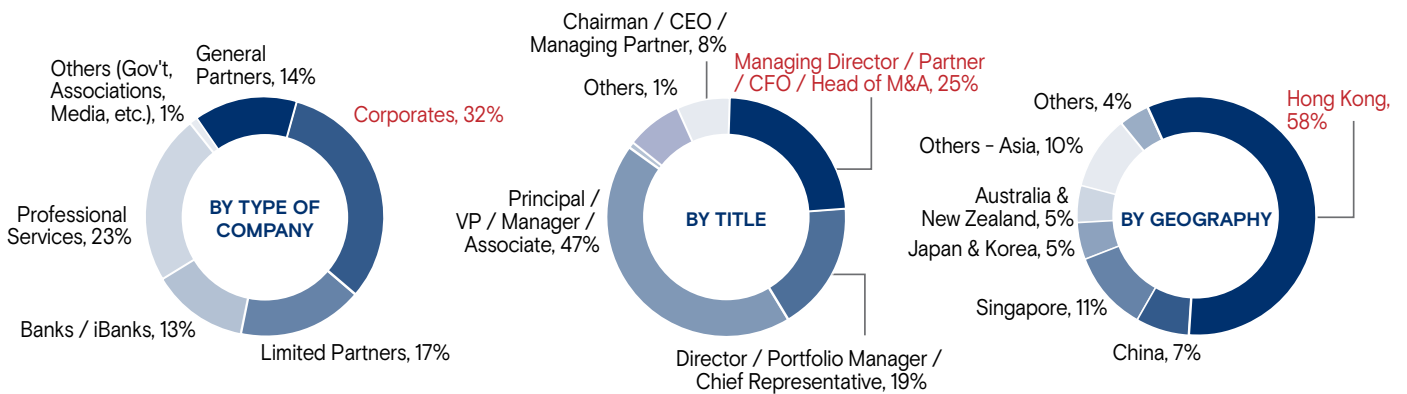

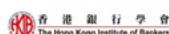
